News from the SUNY PSM Consortium

On April 28, 2014 more than twenty representatives attended the Spring 2014 meeting of the 19 campuses of the SUNY PSM Consortium at SUNY System headquarters in Albany. The Consortium Director, David King, Graduate Dean at SUNY Oswego, began the meeting by showing a video of SUNY Chancellor, Nancy Zimpher's speech at the PSM Milestone event at the Library of Congress last November 12, 2014. Chancellor Zimpher and the SUNY Provost have been strong supporters of the PSM initiatives among SUNY campuses as model partnerships between universities and businesses in New York State to promote economic and workplace development.

Michael Teitelbaum, former Director of the PSM program at the Sloan Foundation, provided a national perspective on PSM initiatives and possible support from various federal agencies. Jim Sterling, Director of the National PSM office at Keck Graduate Institute offered, via video conference, an update on new PSM program affiliations as well as the program assessment and re-affiliation process.

In the afternoon session, Linda Strausbaugh, Professor Emeritus of Genetics and Genomics at the University of Connecticut, facilitated discussion of a variety of PSM program issues: industry advisory boards and partnerships, internships, recruiting, etc. The group then heard a presentation from Julie Shurts from the Educational Testing Service, who discussed the value of E.T.S's Personal Performance Index as a way of assessing non-cognitive skills in admission and post graduation "value added" assessment of our PSM programs. Darren Leva, CEO of IntroMaps, spoke via video conference about the value of using IntroMaps to help PSM students and graduates network among their peers.

The meeting concluded with a review of the resources available on the PSM Milestone website which includes numerous video clips from political, higher education and business leaders, along with several PSM graduates discussing the value of the PSM degree. At the Milestone event, SUNY Cortland was nationally recognized for developing the 300th PSM program. The link is at psmmilestone.com.

The Consortium plans to meet again in the Fall of 2014.

April Workshop 2014 Summary: Workforce Challenges and Opportunities in the Food and Agriculture Industries

Approximately 25 attendees enjoyed the workshop held on April 10-11, 2014 in the secluded Lafayette Hotel and Spa in Lafayette, CA, an hour's ride from San Francisco Airport.

The first day attendees listened to a presentation on food safety from Trevor Suslow from University of California Davis, and learned about agricultural technology from Timothy Connor, Monsanto Corporation. Attendees enjoyed the evening networking reception held in the exclusive Wishing Well Courtvard. The second day, attendees enjoyed hearing from Valerie Mellano, Cal Poly Pomona, about educational opportunities in the food and agriculture industries. An expert panel with Kristen Bennett, Monsanto Corporation, and Kimberly Rodrigues and Bonnie Fernandez-Fennaroli, University of California Davis, discussed perspectives on the high tech workforce needs of the food and agriculture industries. California Secretary of Food and Agriculture Sciences Karen Ross delivered the keynote address and ioined the group for lunch. Attendees also heard presentations on setting up PSM programs, funding models, the importance of industry advisory boards and the affiliation process.

News from the PSM Program in Industrial Mathematics at MSU

Begun in 1999-2000 with initial support from Alfred P. Sloan Foundation, the Professional Science Master's (PSM) in Industrial Mathematics (aka MSIM, Master of Science in Industrial Mathematics) Program at Michigan State University has continued to get national recognition as one of the oldest continuously running PSMs, and received the Board of Directors Award to a Program from



the NPSMA in 2013. The program has been successfully preparing students for their career path in business, government, or industry for fifteen years. The goal of the program is to produce generalized problem solvers of great versatility, capable of moving within an organization from task to task. The graduate will have studied not only the standard mathematical and statistical tools, but also the basic ideas of business and engineering, and will have received training in project management and industrial communication.

The program consists of seven pillars: Survey of Industrial Mathematics (MTH 843, Fall); Projects in Industrial Mathematics (MTH 844, Spring); Certificate in Project Management; Four Electives in Applied Mathematics; Two Electives in Statistics; Four Cognates (computer science, economics, engineering, marketing, and supply chain management etc.); and Portfolio Defense (Spring).

A total of seven MSIM students are graduated this year (see the pictures taken on Graduation Day at MSU in May 2014 above and below). The MSIM Graduates possess the following skills after two-year training for over fifteen years:

- Advanced applied mathematical training.
- Better understanding of business environment.
- Industrial project experience.
- Deeper understanding of computational issues.
- Technical writing skills.
- Good communication skills.

This year 609 finalists were chosen from approximately 7,000 applications. The CSUSM student named as a finalist is a recent graduate of the Professional Science Master's in Biotechnology.
